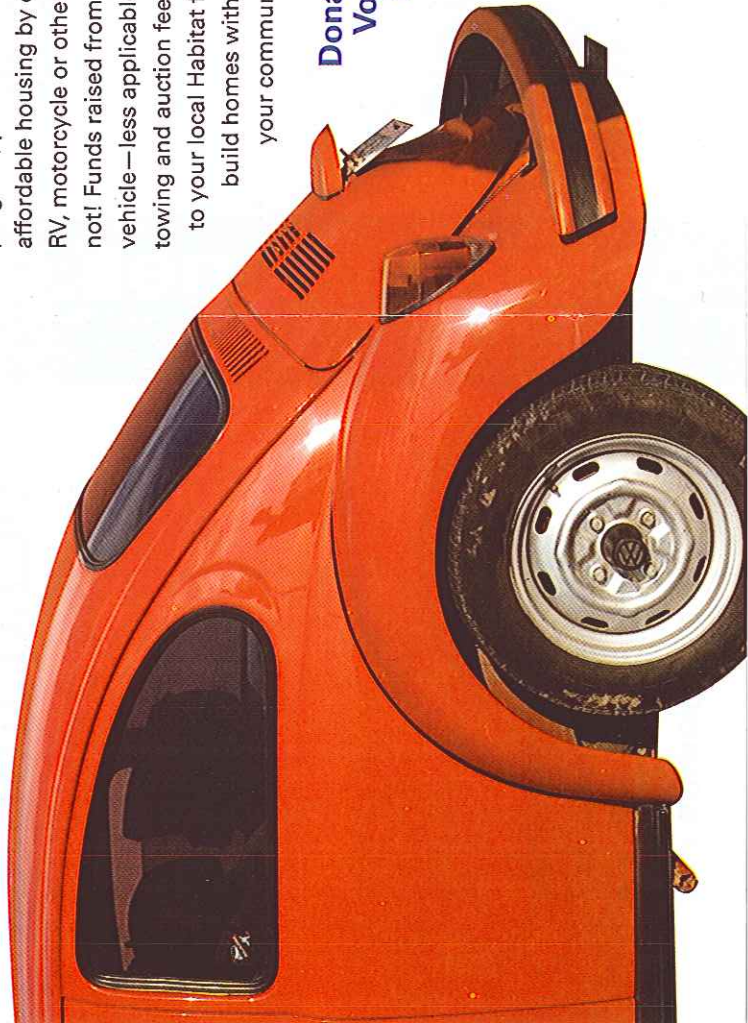

**Cars for Homes™**

Cars for Homes™, Habitat's official car donation program, provides another way to support building affordable housing by donating a car, truck, boat, RV, motorcycle or other automobile - running or not! Funds raised from the sale of your donated vehicle—less applicable program, processing, towing and auction fees—are distributed directly to your local Habitat for Humanity affiliate to help build homes with low-income families in your community.

**Frequently Asked Questions About Cars for Homes™**

**What types of vehicles are accepted?**

Cars for Homes™ accepts most whole automobiles, trucks, motorcycles, boats, airplanes, construction vehicles, trailers and recreational vehicles with proper title documentation.

**What if the vehicle is not running?**

The vehicle need not run, but you will be asked to explain the condition of the vehicle. If the costs of transport and processing fees exceed the auction value of the vehicle, Cars for Homes™ cannot accept the donation.

**How much of my donation goes to house building?**

Every donated vehicle is unique. Processing, towing and auction fees depend on the condition and location of the vehicle. Auction-quality vehicles (late-model, running and in good condition) generate significantly more funds than salvaged or recycled vehicles. Cars for Homes™ program costs are kept as low as possible, and donated vehicles are sold through a national network of diverse venues to optimize revenue for local Habitat for Humanity affiliates.

**What are the tax benefits of donating my vehicle?**

Habitat for Humanity International is a 501(c)(3) nonprofit organization. If you itemize deductions on your income tax return, it may be possible to deduct your vehicle donation. Donors will receive appropriate receipts and should consult their tax adviser and/or the IRS to determine benefits.

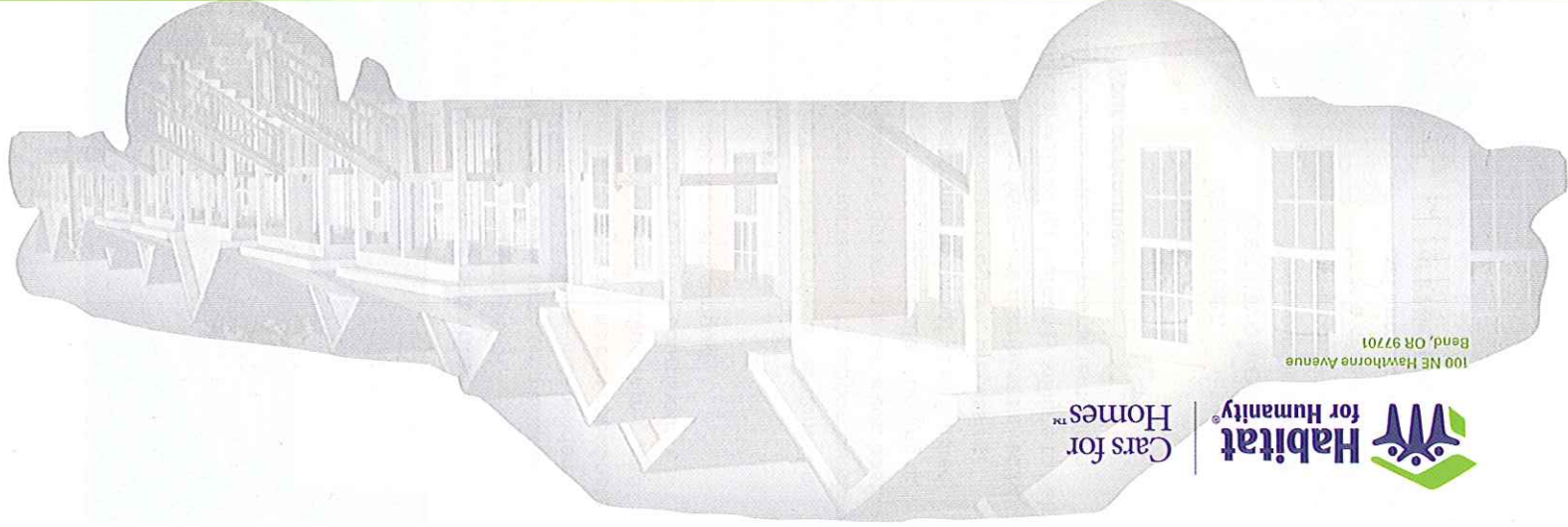

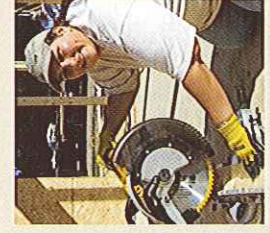


**Habitat for Humanity International**
